Next Sunday. English: Matthew 13:24-52 - "Portraits of The Kingdom-II" **Armenian:** Acts 17:1-15 – "Proclamation and Proof"

Synopsis of the Armenian Message

As we saw last Sunday, Paul and Silas were unjustly arrested, beaten and put in prison. There response to their situation was to pray and praise God. Their focus was on their heavenly Father who is the source of their joy independent from their immediate earthly circumstances. This is a good lesson for us of how to respond to suffering. Lift your focus of yourself and your circumstances and look to God who can help you see His purposes. While they were singing and other prisoners were listening, an earthquake rocked the prison. When the jailer woke up and saw the prison doors open, he assumed that the prisoners had escaped. Aware that this would cost him his life, he decided to kill himself. But Paul assured him that there was no need for that. Suddenly a deep conviction of sin swept over him and he asked Paul and Silas, "Sirs, what must I do to be saved?" Their answer, "Believe in the Lord Jesus, and you will be saved-you and your household." Following a teaching session about the Lord with the jailer and his household they were all baptized. The magistrates seems to have had a change of heart overnight also and wanted the jailer to release Paul and Silas. But Paul refused to leave under such circumstances. Silas and he were Roman citizens and they were unjustly beaten and put in prison. The magistrates came and apologetically begged them to leave the city. They left but not immediately, first they went and encouraged the brothers and then left.

Friends, what this passage teaches us is that; (1) the gospel of Jesus Christ brings freedom and joy even in very difficult times. (2) Just because we are Christians it does not mean that we should forfeit our rights as citizens and allow the authorities to treat us unjustly.
